2. Consider Approval of Resolution Canvassing the Returns and Declaring the Results of the November 4, 2025 Special Election

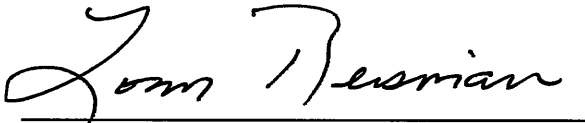
